<b>Name of employment business:</b>	Servoca Education Resourcing
<b>Type of contract you will be engaged under:</b>	Contract for Services (as a temporary worker).
<b>Who will be responsible for paying you</b>	Servoca Education Resourcing
<b>How often you will be paid:</b>	Weekly
<b>Expected or minimum rate of pay:</b>	Not less than the National Minimum Wage. Details can be found here - <a href="#">NMW/NLW Rates</a>

All example pays are based on tax code 1250L W1/M1

<b>Example rate of pay (incl. Holiday Pay):</b>	<b>£100.00</b>
<b>Days worked</b>	<b>5</b>
<b>Gross Pay</b>	<b>£500.00</b>
<b>Deductions from your wage required by law:</b>	<b>Income tax (£51.92)</b> <b>Employee National Insurance (£39.72)</b>
<b>Any other deductions or costs from your wage:</b>	<b>None</b>
<b>Example net take home pay:</b>	<b>£408.36</b>

**EXAMPLE PAY**

(where there is a Student Loan/Postgraduate Loan deduction)

All example pays are based on tax code 1250L W1/M1

<b>Example rate of pay (incl. Holiday Pay):</b>	<b>£100.00</b>
<b>Days worked</b>	<b>5</b>
<b>Gross Pay</b>	<b>£500.00</b>
<b>Deductions from your wage required by law:</b>	<b>Income tax (£51.92) Employee National Insurance (£39.72)</b>
<b>Any other deductions or costs from your wage:</b>	<b>None</b>
<b>Student Loan Plan 1</b>	<b>£11.44</b>
<b>Example net take home pay:</b>	<b>£396.92</b>

If you have a Student Loan Plan 2, the following net pay would be:

<b>Student Loan Plan 2</b>	<b>£0</b>
<b>Example net take home pay:</b>	<b>£408.36</b>

If you have a Postgraduate Loan, the following net pay would be:

<b>Student Loan Postgraduate Loan</b>	<b>£5.77</b>
<b>Example net take home pay:</b>	<b>£402.59</b>

(where there is an Attachment of Earnings order being made)

All example pays are based on tax code 1250L W1/M1

<b>Example rate of pay (incl. Holiday Pay):</b>	<b>£100.00</b>
<b>Days worked</b>	<b>5</b>
<b>Gross Pay</b>	<b>£500.00</b>
<b>Deductions from your wage required by law:</b>	<b>Income tax (£51.92) Employee National Insurance (£39.72) Attachment of Earnings Order (£61.25)</b>
<b>Example net take home pay:</b>	<b>£347.10</b>

**EXAMPLE PAY**

(with pension contributions)

All example pays are based on tax code 1250L W1/M1

<b>Example rate of pay (incl. Holiday Pay):</b>	<b>£100.00</b>
<b>Days worked</b>	<b>5</b>
<b>Gross Pay</b>	<b>£500.00</b>
<b>Deductions from your wage required by law:</b>	<b>Income tax (£51.92) Employee National Insurance (£39.72) Pension contributions (£19.00)</b>
<b>Example net take home pay:</b>	<b>£389.36</b>

(with pension contributions, Student Loan and attachment of earnings order)

All example pays are based on tax code 1250L W1/M1

<b>Example rate of pay (incl. Holiday Pay):</b>	<b>£100.00</b>
<b>Days worked</b>	<b>5</b>
<b>Gross Pay</b>	<b>£500.00</b>
<b>Deductions from your wage required by law:</b>	<b>Income tax (£51.92) Employee National Insurance (£39.72) Pension (£19.00) Student Loan Plan 1 (£11.44) Attachment of Earnings Order (£58.40)</b>
<b>Example net take home pay:</b>	<b>£319.51</b>
